All pending civil jury cases may be set for jury trial for the weeks of:

- Monday, July 18, 2016
- Monday, August 8, 2016

All pending civil non-jury cases may be set for trial for the weeks of:

- Monday, August 15, 2016

All pending criminal cases will be set for jury trial for the weeks of:

- Monday, July 11, 2016
- Monday, August 1, 2016

- \* Non-jury cases may be set for jury weeks, but will be subject to jury cases:
- \* Civil jury cases may be set for criminal jury weeks, but will be subject to the criminal cases:

All pre-trial matters in criminal & civil cases will be set and heard on Friday, July 8, 2016 at 9:00 a.m.

- \* Pretrial matters may be set at other available times, if request is made through the Court Coordinator.
- \* All dilatory pleas, special exceptions and other pre-trial matters including motions in limine and "Daubert" Motions in all cases set will be heard at Pre-Trial. All such matters not presented on or before such time will be considered waived. Pre-trial matters need not be reserved at the call of the docket.
