2018 Property Tax Rates in CITY OF TIMPSON

This notice concerns 2018 property tax rates for CITY OF TIMPSON. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's *effective* tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

Statement of Increase/Decrease

If CITY OF TIMPSON adopts a 2018 tax rate equal to the effective tax rate of 0.338700 per \$100 of value, taxes would decrease compared to 2017 taxes by \$ 126.

The CITY OF TIMPSON will hold a meeting at 05:30 PM on August 21, 2018 at CITY OF TIMPSON to consider adopting a proposed tax rate for tax year 2018. The proposed tax rate is 0.358700 per \$100 of value.

The proposed tax rate would increase total taxes in CITY OF TIMPSON by 5.904931 percent.
