

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.590885 per \$100 valuation has been proposed by the governing body of City of Center.

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for City of Center from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that City of Center may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that City of Center is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 8, 2025 AT 5:00 PM AT City of Center, City Hall at 617 Tenaha Street Center ,Texas 75935.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, City of Center is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of City of Center at their offices or by attending the public hearing mentioned above.

YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by City of Center last year to the taxes proposed to be imposed on the average residence homestead by City of Center this year.

| | 2024 | 2025 | Change |

| Total tax rate (per \$100 of value) | \$0.607620 | \$0.590885 | decrease of -0.016735 per \$100, or -2.75% |
| Average homestead taxable value | \$84,610 | \$91,715 | increase of 8.40% |
| Tax on average homestead | \$514.11 | \$541.93 | increase of 27.82, or 5.41% |
| Total tax levy on all properties | \$2,223,389 | \$2,294,287 | increase of 70,898, or 3.19% |
