

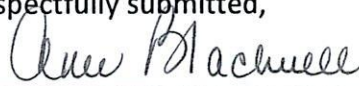
**SHELBY COUNTY TREASURER'S REPORT

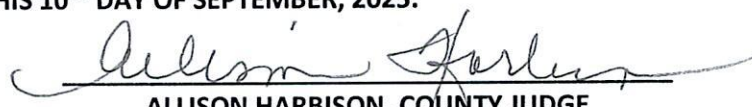

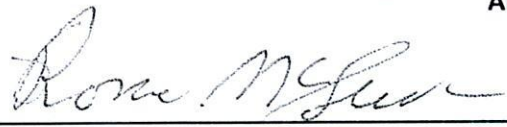
ORDER APPROVING TREASURER'S REPORT

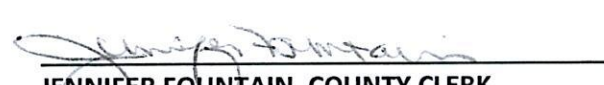

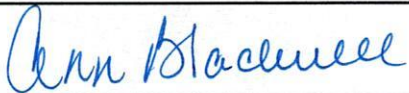
