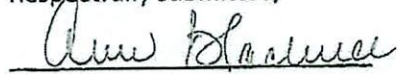


**SHELBY COUNTY TREASURER'S REPORT

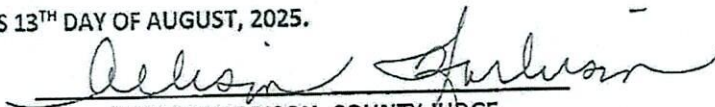

ORDER APPROVING TREASURER'S REPORT

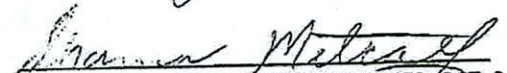

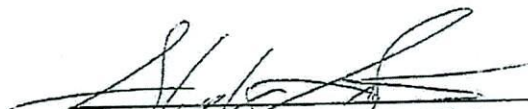
It is **FURTHER ORDERED** that the amounts received and paid from each fund, and the cash balance remaining in the treasurer's custody, are as indicated in the report itself.

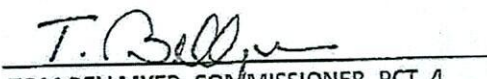

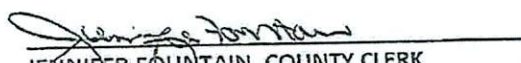
